Comparison of inspiration of Declofenac and local steroids in the controlling of post-operative Cataract surgery inflammation.

Abstract

Purpose: Anti- inflammatory effect evaluation of the sodium Declofenac 0.1% drop and Bethametazone 0.1% drop, and the usage of the both drops at the same time in order to regulating of post-operative cataract surgery.

Methods: This study has been done accidently in randomize clinical trial; 93 ECCE-PC IOL patients under operation were divided in to three function treatment of Betamethasone, Declofenac and Declofenac + Betamethasone. Patients in the 4th ,8th and 35th day after the operation Anterior Chamber reaction (A,C) and conjunctival injection were assisted and compared.

Result: The proportion of reaction (A,C) and conjunctival injection in days of 4th, 8th and 35th after operation in each three groups based on the statistics were equal and no variations has been seen though this treatment. As well no intra ocular pressure IOP were seen over this treatment.

Conclusion: Declofenac 0.1% drop has the same impression in controlling of the inflammation beyond cataract surgery as betamethasone 0.1% drop. And the treatment with the combination of both drops is similar, although betamethasone has more impression in controlling of inflammation after operation, but this difference is not that much observable based on statistics. **Key Words:** Cataract surgery, Post-operative cataract surgery inflammation, Declofenac eye drop, betamethasone eye drop.

Equilibrium is the dominance characteristic of chemical reaction, but velocity and the final limit of reaction doesn't have relationships to each other. When right and lift side reactions' velocity is equal, system reaches to dynamic equilibrium and the concentration is stable. Equilibrium constant (K) shows the ratio of primary materials and products concentration. When the equilibrium is occurred by more concentration of primary materials (K) has less price. Vice versa has much price.

Equilibrium constant and reaction description most often are expressed according to (QC and KC) concentration. We can express (QP and KP) by partial pressure of gasses. The amount of KP and KC have relationships according to the law of ideal gasses.

If KC > QC, give us much production.

If QC >Kc, give us much reactors.

If QC=Kc, no change comes out.

Lechtelier's Principle expresses, if a system is scrambled in equilibrium situation, system carry out the reaction ahead on the way until take away the disorder and established the lost equilibrium.

The variation of concentration causes deficiency of increased part of reaction, or increases the outgoing materials. In reaction that changes amount of moles of gas, in it, the excess of pressure, decreases the moles of gas and deficiency of pressure causes vice versa. The concentrations of parts of equilibrium modify by changing concentration and volume, but (K) is changed by heat.
